Theresa Foxley called the meeting, held in-person at the SLCDA Admin Offices Board Room and via Webex, to order at 9:05 a.m. (* indicates the party attended virtually)

A. Minutes

A motion was made by Theresa Foxley and seconded by John Bradshaw to approve the minutes of November 15, 2023, as presented. All votes were affirmative; motion passed.

B. Director's Report

Bill Wyatt, Executive Director, gave an update to the Airport Advisory Board regarding current events including,

- Bolts were not tight on a Max 9 aircraft. FAA is doing an investigation
- Mon. Jan. 15th reached 32,000 passengers
- All concession are now open
- We are in the late mid budget season- Our March meeting we will go over the budget

C. Airport Redevelopment Program (ARP) Update – Mike Williams, ARP Director, SLCDA

Mike Williams, Airport Redevelopment Program (ARP) Director, presented an update on the ARP (presentation on file). Main points included were:

- Central Tunnel will be opening in October with an incredible sound system, artists with Utah roots and over 100 songs.

Theresa Foxley asked what the function is of the early bag storage. Bill Wyatt explained when passengers arrive early for their flight the system takes the bag and puts it aside until the tag is read again and put with other bags for the flight.

D. Air Service Development Update – Nate Lavin, Air Service Development Manager, SLCDA

Nate Lavin, Air Service Manager, presented an update on Air Service Development (presentation on file).

- Air Service Portfolio 2024
 - SLC serves 98 nonstop destinations.
 - We have 13 Carriers, and we are the 4th Largest Delt Hub
- Airline Announcement
 - o Hawaiian Airlines Nonstop service to Honolulu beginning May 16th
- We expect to finish the year 1% higher than our 2019 numbers in terms of passengers with much more growth in 2024.
- Growth in international traffic is up 19% as of November 2023
- SLC's airline performance is leading the nation with one of the highest average load factors and airline revenue growth among all U.S. large hubs.
- SLC will add seat capacity to the market in 2024 for the first time since 2020.
 - Delta adding 300,000, United adding 100,211 and Frontier 91,864
 - Comparing the first half of last year and the first half of this year we are adding 700,000 departing seats.
- Pratt & Whitney engine recall
 - An estimated 1200 aircraft will need to be inspected.
 - From removal to inspection then back on the aircraft will take 300 days
- Strategic Plan
 - Strengthen and Grow
 - Expand global reach to new international destinations.
 - Increase presence of low-cost carriers
 - Delta and United have added pilots from the regional carriers
- SLC Air Service Strategic Initiatives
 - Strengthen and grow.
 - Expand global reach to new international destinations.
 - Increase presence of low-cost carriers
- Long Term International Strategy
 - New configuration for Delta's Airbus A350. Less passengers and more premium seats
 - The weight of the aircraft will be reduced, improving the performance of the plane.

John Bradshaw asked if the merger between Hawaiian and Alaska Airlines will be affected by the Federal Judge's ruling on the JetBlue and Spirit merger? Nate Lavin explained it's not a big surprise the merger was not approved and there is a lot of optimism that this merger will go through. Nathan Raferty inquired about the increase in seating. Asking what the added capacity will do to ticket prices. Lavin explained that airfare is coming down with the decrease in fuel costs which helps with the operating costs for the airlines.

Bradshaw asked how much growth potential do we have to bring in additional airlines? Wyatt explained it's a constant conversation. We are looking at ways to expand, adding that international gates are common use gates for all international.

Bradshaw also inquired about extending the runways. Wyatt spoke about this being top priority for our planning group. Stating we are working on plans for the future extensions.

Nancy Volmer congratulated Nate Lavin on making the list for 2023 Airport Business Top 40 Under 40. Theresa Foxley also complimented Nate on his data driven analytical approach.

Raferty inquired about what changes we anticipate with the announcement of the Olympics. Wyatt explained we have been staying in touch with the Mayor's office. By the time the Olympics come we will be done with our current projects and have the bugs worked out.

Theresa Foxley adjourned the meeting at 10:25 a.m.





CONSTRUCTION REPORT

CONSTRUCTION

- (1) North Cargo Apron Site Development Substantial completion for this project was issued on December 31, 2024. All punch list items are now complete. Close-out documents are currently being prepared.
- (2) Pump House No. 5 Renovation This project is nearing completion. A final punchlist walkthrough is scheduled for February 22, 2024.
- (3) **Glycol East and Intermediate East Pumpstation Rehabilitation** Construction in the Glycol East station has been completed with only a few minor punch list items remaining. Modifications to the Intermediate East Pumpstation will be done in the Spring of 2024 due to pending weather and deicing operations.
- (4) **Pump Station #9 Renovations -** Electrical and mechanical submittals are 95% completed. The Contractor has completed the vault base and walls except for the lid. Construction is approximately 10% complete. Anticipated completion for this project is March 2025.
- (5) Electrical Vehicle Charging Stations (FY23) Site mobilization has been updated and construction is scheduled to begin on April 1, 2024. Substantial completion is anticipated for November 27, 2024.
- (6) **Equipment Storage Building -** The backfill work is ongoing and a little delayed due to weather impacts. The Contractor is planning on starting the steel column erection and public water and electricity connections at the perimeter the week of February 19, 2024. The project is approximately 35% complete. Substantial completion is anticipated for April 2025.
- (7) **Taxiway F Reconstruction (G-F1)** The bid opening for this project was held on November 30, 2023. The apparent low bidder is Granite Construction. SLCDA is currently waiting for grant approval from the FAA.
- (8) Gateway Building Restroom Renovations The Contractor was issued substantial completion on November 17, 2023. All punch list items have been completed. Close-out documents are being prepared.
- (9) Electrical & Communication Duct Bank from AOC to Gate 7 The Contractor has completed the installation of the duct bank to the existing RMP vault tie-in on the south end of Runway 17/35. The project is in winter shutdown. Work will commence in the spring to complete the finish grading and seeding.
- (10) Gateway Sustainability Display The Contractor was issued substantial completion on December 22, 2023, with one punch list item remaining.
- (11) **Replace PVC Roof Membrane on NS1** The Contractor has started the roofing membrane work. Completion date for this project is April 24, 2024.
- (12) Replace PVC Roof Membrane & Greenhouse Panels on NS14 This project is approximately 90% complete. Substantial completion is anticipated for April 24, 2024.
- (13) **Toilet Carriers Upgrades** The Contractor continues with work on the secure side of the terminal. The project is 98% complete. The anticipated completion date for this project is March 8, 2024.
- (14) **Concourse B Maintenance T.I.** Construction for this project started on January 24, 2024. The under-slab work is complete and interior walls are currently being framed. Exterior walls will begin next month. Substantial completion is anticipated for June 20, 2024.
