

Salt Lake City Department of Airports Fixture and Finish Standards

Section 1. Purpose

Installation standards provide common understanding of Salt Lake City Department of Airports (SLCDA) requirements for tenant improvements involving fixtures and finishes at Salt Lake City International Airport (SLC), South Valley Regional Airport (SVRA), and Tooele Valley Airport (TVA). Installation standards ensure that all such fixtures are compatible with SLCDA fixtures, inventories, and are maintainable by SLCDA, if required.

Section 2.1 Restroom Fixtures

- A. Soap dispensers
 - 1. Counter mounted soap dispensers – Technical Concepts “One Shot” part #750339 – Battery Operated
 - 2. Wall mounted soap dispensers – Deb Foam Dispensers, DEB SBS Grey Marble w/ grn mp, Prod. Code 9125M
- B. Paper towel dispenser: Touch-less paper towel dispenser – Georgia Pacific “enMotion” stainless steel, part #59466, battery operated
- C. Toilet tissue dispenser: San Jamar jumbo roll 9-inch twin, smoke, part# r4090tli
- D. Toilet seat cover dispenser: Bobrick, part # B-22
- E. Sanitary Napkin dispensers: Washroom Accessories, part # U510
- F. Sanitary Napkin disposal container: Bobrick, part #B-270

Section 3. Definitions

Airport: Salt Lake City International Airport (SLC), South Valley Regional Airport (SVRA), and/or Tooele Valley Airport (TVA), collectively.

Contractor: An organization hired by a tenant at the Airport, authorized to do work for and on-behalf of tenant in the state of Utah.

Salt Lake City Department of Airports: Department of Salt Lake City which owns and operates Salt Lake City International Airport (SLC), South Valley Regional Airport (SVRA), and Tooele Valley Airport (TVA).

Tenant: An organization with an executed and current lease agreement at any of the three (3) airports SLCDA manages.

Tenant Lease Space: Space exclusively leased by the tenant in which all of the tenant's passive and active networks can be housed. This space does not traverse any common areas such as hallways, stairs, etc.
